Competition Terms and Conditions

1. The Competition is run by Go Get It a trading name of Go Get It Limited which is authorised and regulated by the Financial Conduct Authority (No. 563873). Registered in England and Wales (No. 05237592). Registered office is at 45 Westerham Road, Bessels Green, Sevenoaks, Kent, TN13 2QB. Go Get It Limited is part of the Markerstudy Insurance Group of companies (“the Promoter”).
2. These terms and conditions apply to **the Promoter’s Competition to win:**
1st Prize - £2500 Cash, a Luxury Pet Hamper and a Portrait of Pet.
2 x 2nd Prize - £500 worth of Wex Photography Equipment vouchers each.
3rd Prize - A Pet Portrait.
There are also monthly prizes awarded each month - 10 x canvas print of the image submitted

Acceptance of these terms and conditions is a condition of entry. By entering into the Competition you agree to be legally bound by these terms and conditions.
3. The Promoter agrees to comply with the provisions of the Data Protection Act 2018 and General Data Protection Regulation (GDPR), including any subordinate legislation made under it and any provision amending, superseding it or re-enacting it (whether with or without modification).
4. In the event of any inconsistencies between these terms and conditions and any other instructions or terms, these terms and conditions shall prevail, except for the Data Protection (DP) terms which can be found on the Promoters webpage, which will prevail.
5. The Competition is open to all residents of the United Kingdom aged 18 or over except employees of the Promoter or its holding or subsidiary companies. In entering the Competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. We may ask you to provide proof that you are eligible to enter the Competition.
6. The Competition will open at 00:01 on 6th June 2019 (“Opening Date/Time”) and will close at 23:59 on 30th November 2019. (“Closing Date/Time”). If you enter either before the Opening Date or after the Closing Date your entry will not be accepted. You can enter each calendar month to a maximum of ten attempts each calendar month, per person.
7. To enter the Competition, follow the link to the Promoter’s website – www.gogetit.co.uk/competition. To win you must enter your details, enter information about your pet and upload a picture/video of your pet. You will also be required to consent to the DP terms and to the transfer of moral rights/copyright. You will then be entered into a prize draw. At the end of each month the Promoter will select a winner, who will win a canvas print of their uploaded photo/still video. The winner will be contacted via direct message or telephone letting them know they have won.
8. After the Closing Date of the Competition, the Promoter will select an overall first and second place winner. The third place winner will be selected via a poll on the Competition webpage. You are able to promote your entry for votes on Social Media. The top three individuals in the poll will go through to a judging panel, where a winner will be decided by the Promoter. Winners will be contacted directly by the Promoter by the 10th December 2019. Once the winner has been announced, the Promoter will (where relevant) contact the winner directly to obtain their bank details for the transfer of the prize only. The Promoter will delete these bank details within 2 days of the payment being made. The Prize is awarded

conditionally upon the Winner's acceptance of it. If the Prize is unclaimed within 3 working days of the Winner being notified, the Prize shall be deemed unclaimed or unaccepted and a supplementary Winner may be chosen at the Promoter's sole discretion. The Promoter shall not be held responsible for non-delivery of the Prize to the postal address provided or any failure by the Winner to take advantage of the Prize for any reason and no alternative will be provided. It is your responsibility to inform the Promoter of any change to your contact details such as telephone number and email address.

9. The Promoter accepts no responsibility for entries submitted incorrectly or delayed, that do not comply with the terms and conditions.
10. The Promoter's decision as to entrants taking part and the Winner is final. No correspondence relating to the Competition will be entered into.
11. Our liability to you for any direct, indirect or consequential damage or loss is excluded to the maximum extent permitted by law and in particular we will have no liability to the Winner or to any other third party in respect of any issue which affects the quality or fitness for any particular purpose of the Prize or any damage or loss resulting from making use of the Prize. You further accept that any replacement or substitution of the Prize is at our sole discretion and we are under no obligation to do so.
12. The Prize is non exchangeable, non-transferable and no cash alternative is available. There is no cost to enter the Competition. The Winner agrees not to sell, offer to sell or use the Prize for any commercial or promotional purpose (including placing the Prize on an internet auction site).
13. The Promoter, reserves the right, at their discretion, to:
 - (i) amend these terms and conditions; and
 - (ii) disqualify any entrants who do not comply with these terms and conditions or has acted fraudulently in any way; and
 - (iii) suspend or cancel the Competition at any time and without providing any prior notice, if in its opinion it is deemed necessary or if circumstances arise outside its control; and
 - (v) substitute the Prize or any element of the Prize including the Prize value in the event that the Prize cannot be provided to the Winner.
14. The Promoter cannot accept any responsibility whatsoever for any technical failure or malfunction, availability or functionality or otherwise or any other problem with any server, system, network or mobile operator or service provider or otherwise which may result in any registration not being properly logged, not recorded or recognised.
15. Nothing in these terms and conditions shall limit or exclude the Promoter's liability for:
 - a) death or personal injury caused by its negligence;
 - b) fraud or fraudulent misrepresentation.
16. Subject to clause 14 and to the maximum extent permitted by law, the Promoter shall not be liable for any claims or actions of any kind whatsoever for damages or losses to persons, the Winner, of property which may be sustained in connection with the receipt, ownership and/or use of the Prize or any element of the Prize, any acts or omissions of its agents.

18. You confirm that you have read and understood that by entering this Competition you will transfer the moral rights and copyright in the photo/video and that you have the necessary permissions to effect this transfer.
19. If any of these terms and conditions are found by a competent court or other competent authority to be void or unenforceable, that term or condition shall be modified to the minimum extent necessary to make it valid, legal and enforceable.
20. This Competition is governed by English law and is subject to the exclusive jurisdiction of the courts of England and Wales.
